

Turnover and cashback calculation rules

Cashback refunds are not intended for the following transactions:

- When withdrawing funds from a payment card (transactions such as ATM-Cash, Pos-Cash);
- Card-to-card transfer operations (Card-to-Card, Visa Direct, Mastecard Money Send);
- Receipt of funds on the balance of electronic wallets (QIWI, YandexMoney, etc.);
- Debt repayment online payments (mortgage, consumer loan, installment, grace period, etc.);
- Online payments made through the State Payment Portal (GPP) (Utilities, government payments, fines, taxes, customs duties, etc.).
- When paying to mobile operators.
- ASAN payments
- Public transport fees

All of the above types of transactions will not be taken into account when calculating the total amount of turnover for the reporting period.
